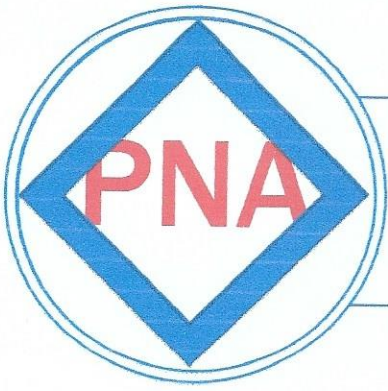
Good afternoon family
