## KRSCNA RD Report 3-16-25

The Kentuckiana-Bluegrass Appalachia Region of Narcotics Anonymous (KBARNA) met virtually Sunday February 23<sup>rd</sup>. We discussed the interim Conference Agenda Report (CAR), and the future of KBARNA.

One issue discussed was the short amount of time between the release of the interim CAR and the conference. Since amendments to CAR motions are allowed, a lot of people didn't have an opportunity to review the amended motions with their groups. Some people didn't even know there were amendments. This issue was addressed in CAR motions 6 and 7.

The Bluegrass Appalachian (BARSCNA) RD stated that his term was over after the 2026 World Service Conference (WSC) and they currently do not have an RDA or anyone to replace him. He suggested that we consider dissolving KBARNA as a service committee and joining the Regions permanently.

BARSCNA will be hosting the Southeast Zonal Forum, July 25<sup>th</sup>-27 2025. It was suggested that they hold it in Frankfort KY to make it more accessible to members from Kentuckiana Region. It was also asked if Kentuckiana Region would be interested in financially contributing to the function to add more service-related workshops.

Kentuckiana Region will be hosting The Southern Zonal Forum October 24<sup>th</sup>-26<sup>th</sup> 2025. Location to be announced.

The Interim WSC was held February 28<sup>th</sup>-March 1<sup>st</sup>, 2025. 144 voting members participated. 123 of 128 seated regions, 6 of 6 seated zones and 15 board members. 89 alternate regional and or zonal delegates were also present. 44 countries were represented at the conference. The board members choose not to vote on any of the motions allowing only delegates to vote. Motion 1 allowed for motions having consensus (80% or more) in the initial straw poll to be considered the final vote. (The initial straw poll was completed February 19<sup>th</sup>, 2025) Since it passed with strong support (2/3rds) all motions expect for motions 6 and 7 and their amendments automatically passed.
