KRSCNA Treasurer's Report for January 15, 2023

Hello Family,

On January 1, 2023 I went to our bank account to print the bank statements and see how the account looked and I noticed an EFT withdraw for \$ 18,868.58 had happened. My heart skipped a beat and my stomach flipped over. I'm like holy shit someone has hacked our account. I tried to call the 800 number for our bank but it was a holiday. I called Tony and told him what was going on and he told me to call the bank on Tuesday and tell them what had happened. Long story short I filed a Fraud incident report and answered a bunch of questions asked by the bank and I froze our account until I heard back from them.

On Saturday 1-7-23 I called the banks fraud department number they gave me and was told our money had been put back into our account. Right now our account is still froze until we decide what we Wanted to do. Re-open our account or start a new account with a new account number. Our debit card wasn't compromised and they told me someone used the routing and account number. Tony said it most likely was a bank teller error and it happens more than people realize. Anyway all our money is there and I'm grateful we got it back.

We now have the bank statements going to a different address than mine but I downloaded the November & December bank statements along with a Bank balance from 1-12-2023 for our meeting today. I also have the quicken register report. We have a current balance of \$ 27,695.48 in our account. I wrote two checks in the past two months. One to the World Service Office of NA for \$ 5,000, the other check went to WD Insurance Co. for liability insurance for \$ 1,123.02. I did deposit five checks and those checks are listed on the check register report and below. If anyone has any expense's you can mail the receipts so I have them to file. 

Helpful Information RE CAR/CAT

The Conference Agenda Report (CAR) contains the reports, proposals, and motions brought before the conference by the Regions, Zones and World Board. The Fellowship is asked to consider and form a fellowship wide group conscience on these items.

The Conference Approval Track (CAT) Contains a variety of material to be considered at the upcoming World Service Conference that was not included in the Conference Agenda Report. Having a separate approval track from the CAR allows for materials intended for committees and boards, such as handbooks or service manuals, to be distributed directly to conference participants 90 days before.

The Three Approval Tracks There are three different types of approval tracks for NA literature and service material: fellowship-approved, conference-approved, and board-approved.

Fellowship-approval Track The fellowship-approval track consists of recovery literature and literature dealing with our core principles. This material is sent to the fellowship for review and input, and then "approval" drafts of these texts are included in the Conference Agenda Report (CAR) to be voted on as part of old business at the World Service Conference.

Conference-approval Track Conference-approved material includes NA handbooks and service booklets that tend to convey NA's fundamental ideas about certain areas of service. These pieces may or may not have been sent out for review and input according to the specifics of the project plan presented to the WSC. Approval drafts are included in either the CAR or the Conference Approval Track mailing to be voted on at the World Service Conference.

World Board-approval Track board-approved materials include "articles/bulletins concerning service work, NA-related philosophical issues, NA's Twelve Traditions, and NA's Twelve Concepts for Service. Papers for presentation at professional events, when they are published for broad distribution to the fellowship or the general public, are [also] included in this category."

Zonal Forums Service-oriented sharing and/or business sessions composed of multiple regions that provide means by which NA communities can communicate, cooperate, and grow with one another

Fellowship Intellectual Property Trust (FIPT) A legal trust that serves as custodian for NA's recovery literature and logos (trademarks). The FIPT's purpose is to ensure that NA's property is held in trust for all of NA and kept safe for members yet to come. It explains how NA's literature and trademarks are managed and protected for the benefit of the Fellowship as a whole.
