### **RD Report:**

“NAWS is now on Facebook if you would like to join that, it’s @NA World Services. For the first time there’s surplus merchandise from the world convention is available. It’s WCNashop.com, so go pick up your gifts for Christmas. Membership survey is online right now at NA.org/survey. Also, the “Loner, For Those in Isolation” is being revised. You can submit your input also under projects and surveys at NA.org. The CAR is coming up on us and this is where we will have to have a little bit of a discussion. It should be out November 8<sup>th</sup> or before then. There should be 12 motions and the 2025 conference is an intern conference, it is virtual but there’s going to be a 90-day period between the CAR and the conference. So, we will only have 1 regional meeting in between so if we want to have CAR workshops, we must get on it. The conference is in February 28<sup>th</sup> - March 1<sup>st</sup>. It is virtual. We need to discuss the policy change of the terms of the RD, if we are going to extend as the rest of the conference did to go to 3-year cycle because the conference will be on May 26<sup>th</sup>. I know I have been absent the last few months because of personal stuff, but if you want me to stay on for that year I’m cool with that and that will keep us on track with the conference cycle, otherwise if I end at the end of this conference then there’s only a year for the next person and they’ll be stopping in the middle a year later, and this is what needs to be addressed.”

- Frank H. raises questions about the status of BARCNA and the 2 regions still functioning together for that conference agenda. RD states he reached out to them recently and as far as he knows it should still be happening, but no one has met. He will reach out to Shane who is the RD from Bluegrass and see what’s going on. Frank says we need some

clarification to find out how we are going to proceed. Questions raised on whether Mikey was going to go represent at the conference, and if Katlyn was the alternate? Clarification still needed. Tony says the next meeting of KBARNA is supposed to be in February and I know I have a \$193 check for KBARNA, so we got money, but I don't know if the committee is still viable. Question on whether Kevin is going to facilitate that coordination, he says he will.

### **RDA Report:**
