N.A.C.K. Area Report JULY 2021 Jackie G., RCM alternate

AREA MEETINGS MONTHLY

Area is meeting hybrid monthly; we are slowly reestablishing our in person meetings; most meetings are including hybrid Zoom options and we have a number of out of state NA members who contribute to local home groups and carry the message; this helps us immensely as area meetings are mostly small meetings; we invite any regional NA member(s) to attend; contact Jackie G. For IDs and schedule if you'd like to speak or just visit a rural NA group.

PR updates

A local outpatient service is opening in Campbellsville, KY They contacted NA for info on meetings and offered to make donations to local NA groups as their clients (addicts) will be attending local meetings soon; donations were declined; a meeting list and contact numbers were provided to the outpatient coordinator who is an AA member. We were clear about what NA can offer

The Oxford House group is opening a women's house in Campbellsville this summer; yes, an outside issue, and yet the biggest obstacle for women in recovery in NA locally has been no housing options. We see this as a positive outside issue which could affect newcomer women in NA. Too often we forget that once the addict gets to the rooms, they are often still homeless or living in using environments. While NA is NOT about housing, it is still something which may affect our ability to sustain local members once they get clean.

COVID-related ongoing issue

A local clubhouse established a 30 person capacity rule; NA groups meeting there must comply; on Saturdays, a local treatment center sends a large number of newcomers; when the 30 number is exceeded, home group members have left the building in order to make room for newcomers. However, this presents more work for the few home group members left in the room. Usually meetings in the area are from 4-10 people, but the local treatment center of 100 beds creates an ongoing awareness of our limitations.. We are trying to maintain a balance of carrying the NA message without direct affiliation. So far, so good....

EXPANDING OUR LOCAL SERVICES

We are hoping that Marion County NA groups will join our area. Area trusted servants will make a road trip July 25 for an NA birthday meeting in Lebanon and will make a formal invitation..We continue to distribute NA Basic Texts that region gifted to this area. The latest. NA member who received one had 8 days. Clean. They were grateful to get a Basic Text with their white keytag. It's a great time to serve in NA.. The end
